#### RISKS COVERED

#### **Risks Clause**

#### 風險條款

#### "Both to Blame Collision" Clause

In the event of any claim by shipowners under the said Clause the Assured agree to notify the Underwriters who shall have the right, at their own cost and expense, to defend the Assured against such claim.

#### **General Exclusion Clause**

- 4 In no case shall this insurance cover

  - This exclusion shall not apply where this insurance has been assigned to the party claiming hereunder who has bought or agreed to buy the subject-matter insured in good faith under a binding contract.

#### **Unseaworthiness and Unfitness Exclusion Clause**

- 5.1 In no case shall this insurance cover loss damage or expense
- unseaworthiness of vessel or craft, or unfitness of vessel 5.1.1 or craft for the safe carriage of the subject-matter insured, where the Assured are privy to such unseaworthiness or unfitness, at the time the subject-matter insured is loaded therein
- unfitness of container liftvan or land conveyance for the 5.1.2 5.1.2 safe carriage of the subject-matter insured, where loading therein is carried out prior to attachment of this insurance or by the Assured or their servants.

#### **DURATION**

#### **Transit Clause**

8

- 8.1 This insurance attaches from the time the goods leave the warehouse or place of storage at the place named herein for the commencement of the transit, continues during the ordinary course of transit and terminates either
- 8.1.1 or place of storage at the destination named herein.

- 8.3 This insurance shall remain in force (subject to termination as provided for above and to the provisions of Clause 9 below) during delay beyond the control of the Assured, any deviation, forced discharge, reshipment or transhipment and during any variation of the adventure arising from the exercise of a liberty granted to shipowners

#### **Termination of Contract of Carriage Clause**

#### **Change of Voyage Clause**

#### **CLAIMS**

#### **Insurable Interest Clause**

#### **Forwarding Charges Clause**

In the event of claim the Assured shall provide the Underwriters with evidence of the amounts insured under all other insurances.
