### 1. PERILS

Subject always to the exclusions hereinafter referred to, this 於適用後列除外規定之情況外,本保險 insurance covers loss of or damage to the Vessel caused by

- 1.1. war civil war revolution rebellion insurrection, or civil strife arising therefrom, or any hostile act by or against a belligerent power
- 1.2. capture seizure arrest restraint or detainment, and the 1.2. 捕獲、查扣、拘押、禁制或扣留及 consequences thereof of any attempt thereat
- 1.3. derelict mines torpedoes bombs or other derelict weapons of 1.3. 棄置之水雷、魚雷、炸彈或其他棄

### 2. INCORPORATION

## 1. 承保風險

承保下列事項所致船舶之毀損滅失:

- 1.1. 戰爭、內戰、革命、叛亂、暴動、 或前述各項所生之民爭或由或抵抗 敵對勢力之任何戰爭行為
- 其任何後果或任何威脅
- 置之戰爭武器
- 爭之人、騷亂或民亂
- 於政治動機所為之人。

#### 3. DETAINMENT

In the event that the Vessel shall have been the subject of capture seizure arrest restraint detainment confiscation or expropriation, and the Assured shall thereby have lost the free use and disposal of the Vessel for a continuous period of 12 months then for the purpose of ascertaining whether the Vessel is a constructive total loss the Assured shall be deemed to have been deprived of the possession of the Vessel without any likelihood of recovery.

## 4. EXCLUSIONS

This insurance excludes

- 4.1 loss damage liability or expense arising from
  - 4.1.1 any detonation of any weapon of war employing atomic or nuclear fission and/or fusion or other like reaction or radioactive force or matter, hereinafter called a nuclear weapon of war
  - 4.1.2 the outbreak of war (whether there be a declaration of war or not) between any of the following countries: United Kingdom, United States of America, France, the Russian Federation, the People's Republic of China
  - 4.1.3 requisition, either for title or use, or pre-emption
  - 4.1.4 capture seizure arrest restraint detainment confiscation or expropriation by or under the order of the government or any public or local authority of the country in which the Vessel is owned or registered
  - 4.1.5 arrest restraint detainment confiscation or expropriation under quarantine regulations or by reason of infringement of any customs or trading regulations
  - 4.1.6 the operation of ordinary judicial process, failure to provide security or to pay any fine or penalty or any financial cause
  - 4.1.7 piracy (but this exclusion shall not affect cover under Clause 1.4),
- 4.2 loss damage liability or expense covered by the Institute Time 4.2 協會定時船體條款 1/10/83(包括四 Clauses-Hulls 1/10/83 (including 4/4ths Collision Liability Clause) or which would be recoverable thereunder but for Clause 12 thereof,
- 4.3 any claim for any sum recoverable under any other insurance on the Vessel of which would be recoverable under such insurance but for the existence of this insurance.
- 4.4 any claim for expenses arising from delay except such 4.4 遲延所生費用之任何求償,然該費 expenses as would be recoverable in principle in English law and practice under the York-Antwerp Rules 1974.

## 5. TERMINATION

5.1 This insurance may be cancelled by either the Underwriters or 5.1 本保險得經保險人或被保險人以七 the Assured giving 7 days notice (such cancellation becoming effective on the expiry of 7 days from midnight of the day on which notice of cancellation is issued by or to the Underwriters). The Underwriters agree however to reinstate this insurance subject to agreement between the Underwriters

## 3. 拘留

## 4. 除外不保事項

本保險除外不保

- 4.1 下列事項所生之滅失、毀損、責任 或費用
  - 4.1.1 任何運用核子或原子分裂及或 融合或其他類似反應或輻射力 或物質之任何戰爭武器(以下 稱為核子戰爭武器)之爆裂
  - 4.1.2 下列任何國家間爆發戰爭(無 論是否有無宣戰): 英國、美國、法國、蘇聯、 中國
  - 4.1.3 徵用或優先承購
  - 4.1.4船舶所有權國或登記國政府或 任何公眾或當地主管官署所為 或下令之捕獲、強占、拘押、 禁制、扣留、沒入或徵收
  - 4.1.5 依檢疫法規或由於違反任何關 税或貿易規章之拘押、禁制、 扣留、沒入或徵收
  - 4.1.6 一般司法程序之運作,疏於提 供擔保或支付任何罰金或罰款 或任何財務原因
  - 4.1.7 海盜 (然此除外項目不影響條 款 1.4 之承保),
- 分之四碰撞責任條款)所承保或依其 條款12可求償之滅失、毀損、責任 或費用,
- 4.3 依船舶任何其他保險或因本保險而 存在之保險可求償任何數額之任何 求償,
- 用依英國法原則或依1974年約克安 特衛普規則可求償者除外。

## 5. 終止

- 5.2 Whether or not such notice of cancellation has been given this 5.2 於下列情況發生時,無論有無解約 insurance shall TERMINATE AUTOMATICALLY
  - 5.2.1 Upon the occurrence of any hostile detonation of any nuclear weapon of war as defined in Clause 4.1.1 wheresoever or whensoever such detonation may occur and whether or not the Vessel may be involved
  - 5.2.2 upon the outbreak of war (whether there be a declaration of war or not) between any of the following countries: United Kingdom, United States of America, France, the Russian Federation, the People's Republic of China
  - 5.2.3 in the event of the Vessel being requisitioned, either for title or use.
- 5.3 In the event either of cancellation by notice or of automatic 5.3 因第 5 條有解約或自動終止或船舶 termination of this insurance by reason of the operation of this Clause 5, or of the sale of the Vessel, pro rata net return of premium shall be payable to the Assured.
